ing was well attended with lots of lively discussion. Votes were counted beforehand, and the membership did vote to adopt the proposed bylaw amendment/replacement. Among other things, that means the number of directors will drop to seven. The board made the decision to do this over a two year period, going to eight this year and seven next year.

Beyond the annual meeting and sale, how do we best bring the membership together now and in the future? We are too small of an organization to toy with the idea of splitting. Trying to avoid that is why I ran for the board three years ago after many, many years off. I suppose with any organization with a varied of membership as we have, some differences of opinion are inevitable. For several years leading up to three years ago, there was a fairly large, and growing, number of members who felt disenfranchised and were preparing to abandon the APSA, possibly starting a new Polypay registry. That seemed to me to be a very poor idea. Now I hear there are other members who are feeling disenfranchised and are considering starting a new Polypay registry. That still seems to me to be a very poor idea. I can assure all that no one on this board desires to disenfranchise anyone, as many remember well how they felt. I will grant an assumption that previous boards did not intend to disenfranchise anyone either.

So, now that people on both "sides" of this divide have felt both sides, how about we all come together, start communicating better with each other, support each other in our various efforts even if it's not something we're interested in, and concentrate on making/keeping Polypays the premier seed stock breed in the nation. We all have much more in common than we have differences. It's up to us, it's up to you, whether we spend efforts squabbling with each other or supporting each other.

Fee Change

It's been many years since there has been an increase in registration and transfer fees in the APSA. We recently had an increase in what we are charged by our registry to do the registrations. We didn't raise our fees last year to cover this, but the board feels we need to this year. Rather than raising both registrations and transfers, the board decided to raise only the transfer fees from \$5 to \$7. This will take effect August 1. Registrations will remain at \$5 for members.
